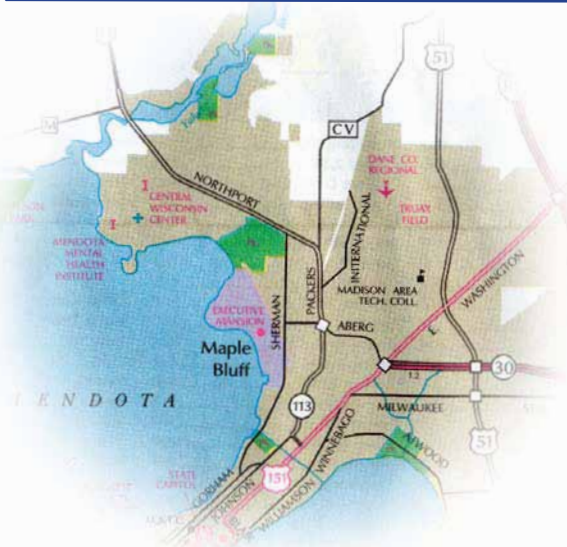
Membership Meetings
